NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. BY ENTERING, ENTRANT AGREES TO BE BOUND BY THESE OFFICIAL RULES AND THE DECISIONS OF THE SPONSOR, WHICH SHALL BE FINAL IN ALL RESPECTS.

1. ELIGIBILITY: The Sweepstakes is open to legal residents of the 50 United States and the District of Columbia who are eighteen (18) years of age or older (nineteen (19) years of age or older if a resident of Alabama or Nebraska) at the time of entry. Void where prohibited. The following persons are not eligible to participate: employees, contractors, directors and officers of Advance Auto Parts (“Sponsor”), Genesco Sports Enterprises, Inc. 2. SWEEPSTAKES TIMING: The Sweepstakes begins at 12:00:00 a.m. Eastern Time (“ET”) on August 15, 2022 and ends at 11:59:59 p.m. ET on September 9, 2022 (“Sweepstakes Period”). The time clock of the Administrator shall be the official time-keeping device.

(a) TWITTER: During the Sweepstakes Period, watch for Sponsor’s Sweepstakes posts (each a “Twitter Sweepstakes Post”) from the @AdvanceAuto Twitter handle requesting eligible entrants to retweet the Twitter Sweepstakes Post with hashtags #AdvanceTheDodgers #Sweepstakes and tag @AdvanceAuto (“Tag”) (altogether the retweet, Hashtags and Tag, the “Entry”) to receive one (1) entry into the Twitter Random Drawing (defined in Section 4). You must be a registered user of Twitter and follow Sponsor’s handle @AdvanceAuto on twitter.com/AdvanceAuto (“Web Site”) to participate. If you do not have a Twitter account, follow the onscreen instructions to register for a free Twitter account at twitter.com. To become a follower of @AdvanceAuto, visit Twitter.com/AdvanceAuto and follow as indicated. Additionally, your Twitter setting must be set to “unprotected” and “public” in order for your tweet to be viewable by Sponsor and Administrator and to be contacted by Sponsor or Administrator if you are selected as a winner. Additionally, do not delete your Entry so that it remains viewable; your retweet must be viewable in order to be considered for the Sweepstakes; deleting your retweet will affect the ability to contact you if you are selected as a potential winner.

Twitter Sweepstakes Post Schedule: August 15, 2022; August 19, 2022; August 31, 2022; and September 6, 2022

(b) INSTAGRAM: During the Sweepstakes Period, watch for Sponsor’s Sweepstakes posts (each an “Instagram Sweepstakes Post”) from the @AdvanceAuto Instagram handle requesting eligible entrants to comment on the Instagram Sweepstakes Post with hashtags #AdvanceTheDodgers #Sweepstakes (altogether the Hashtags and comment, also an “Entry”) to receive one (1) entry into the Instagram Random Drawing (defined in Section 4). You must have an Instagram account and follow Sponsor’s handle @advanceautoparts on <https://www.instagram.com/advanceautoparts/> to participate via Instagram. If you do not have an Instagram account, one can be opened for free by visiting instagram.com and following the appropriate link to download the

free Instagram application. To become a follower of @advanceautoparts, visit [instagram.com/advanceautoparts](https://www.instagram.com/advanceautoparts) and choose to follow. Your Instagram setting must be set to “unprotected” and “public” in order for your Entry to be viewable by Administrator and allow direct messages from anyone so that you may be contacted by Administrator if you are selected as a potential winner.

Instagram Sweepstakes Post Schedule: August 15, 2022 and September 9, 2022

For both Twitter and Instagram entry methods: The hashtags **MUST** be included in order for your Entry to be valid. By using the hashtags, entrant is consenting to receive direct messages via Twitter or Instagram (depending on method of entry associated with the potentially winning Entry) if they are selected as a potential winner.

Any attempt by you to obtain more than the appropriate number of Entries by using multiple and/or different Twitter or Instagram accounts, registrations, or email addresses will void all Entries. A potential winner may be requested to provide Sponsor with proof that he or she is the authorized account holder of the Twitter or Instagram account associated with the winning Entry and an eligible entrant.
