1. ELIGIBILITY: The Sweepstakes is open to legal residents of the 50 United States and the District of Columbia who are eighteen (18) years of age or older (nineteen (19) years of age or older if a resident of Alabama or Nebraska) at the time of entry. Void where prohibited. The following persons are not eligible to participate: employees, contractors, directors and officers of Advance Auto Business Support, LLC (“Sponsor”), Genesco Sports Enterprises, Inc. 2. SWEEPSTAKES TIMING: The Sweepstakes consists of thirteen (13) non-consecutive entry periods (each an “Entry Period”). Each Entry Period corresponds to a tweet made by the Sponsor on twitter.com/AdvanceAuto (each a “Twitter Sweepstakes Post”) and begins at the time of the Twitter Sweepstakes Post on the “Twitter Sweepstakes Post Date / Entry Period Start Date” and ends at 11:59:59 p.m. Eastern Time (“ET”) on the “End Date” as outlined in the table below. The time clock of the Administrator shall be the official time-keeping device.

3. HOW TO ENTER: For each Entry Period, watch for a Twitter Sweepstakes Post from the @AdvanceAuto Twitter handle requesting eligible entrants to retweet the Twitter Sweepstakes Post with hashtags #AdvanceTheCheckeredFlag #Sweepstakes and tag @AdvanceAuto (“Tag”) (altogether the retweet, Hashtags and Tag, the “Entry”) to receive one (1) entry into the random drawing corresponding to the Entry Period in which your Entry was received. See Section 4 for random drawing details.

Limit one (1) Entry per person per Entry Period. Proof of submitting an Entry will not be deemed by the Sponsor as proof of entry into this Sweepstakes. See below for additional entry details.

You must be a registered user of Twitter and follow Sponsor’s handle @AdvanceAuto on twitter.com/AdvanceAuto (“Web Site”) to participate. To become a follower of @AdvanceAuto, visit Twitter.com/AdvanceAuto and follow as indicated. Additionally, your Twitter setting must be set to “unprotected” and “public” in order for your tweet to be viewable by Sponsor and Administrator and to be contacted by Sponsor or Administrator if you are selected as a winner. Additionally, do not delete your Entry so that it remains viewable; your retweet must be viewable in order to be considered for the Sweepstakes; deleting your retweet will affect the ability to contact you if you are selected as a potential winner.

RANDOM DRAWING/ODDS: One (1) potential winner will be selected for each Entry Period (except for Entry Period 8 in which two (2) potential winners will be selected) in a random drawing on or about the corresponding Drawing Date listed in Section 2 from among all eligible entries received for the corresponding Entry Period (each an "Entry Period Drawing").
